MOTION:	To Purchase an initial supply of 5000 contact cards at a cost of less than .02 cents per card. Our area's information will be on one side. A QR code to obtain meeting list information and quick access to the helpline on the other side. The QR code enables the addict to find meeting not just in Gold Coast but nationally and internationally. By selecting the meeting info prompt and then providing the city or zip code, the next five nearest meetings are texted and delivered by voice. If the addict seeks more information they will have our area's website listed on the other side. Asking the area for \$100 or less and 50 cards will be distributed to each group for an initial supply at no cost.		
INTENT:	To Provide an addict with the most accurate meeting list information since printed meeting lists can become quickly obsolete. Essentially eliminates addicts going to meetings that don't exist. Saves our area money since contact cards are 6X less expensive than printed meeting lists.

All nominees, even with only one nomination, must go back to the groups for a vote and brought back to the ASC for election. Answers to questions will be submitted in the area minutes when nominees are referred to Groups. All nominees are required to attend the ASC for elections in August. If a nominee is not present for elections, his/her nomination will be withdrawn. Voting is done by a show of hands: positions with only one (1) nomination require 2/3 majority; positions with two (2) require only a majority; refer to policy for procedures for handling three (3) or more nominees for the same position.

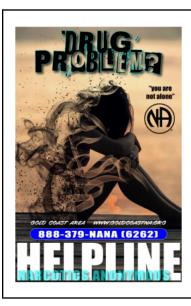
